SHORT DESCRIPTION

The main objective of this course is to introduce students to the historical, political, cultural, and socioeconomic evolution of the idea of Europe. It will facilitate understanding of the stages, protagonists, and sociopolitical currents of the different historical periods covered. While traditionally, the emphasis has been on divisions within Europe, conflict analysis, etc., we will instead emphasize and address all those aspects that have generated a common identity that transcends differences.

METHODOLOGY

The comprehensive learning of any historical subject requires a necessary effort of personal discovery on the part of the student, duly supervised by the professor. The professor is primarily responsible for lectures, support, and academic supervision; however, the student is responsible for active participation in their own learning, the assimilation of topics, and the development of their own critical thinking. To this end, each student must participate in collaborative projects, present a group project in class, and participate in discussions. They may also complete freely chosen optional assignments with the help of the professor. This method not only aims to develop skills specific to the subject area, but also those generic to the degree/course listed above. The limited number of contact hours allocated to this subject requires strict control over time allocation. Taking all this into account, a tight schedule has been developed that assigns each week to the study of a specific topic.

GROUP ACTIVITY	The topics for group work will be explained in the first classes. Readings and presentations, as determined by the professor. Failure to attend the presentation will result in a 0 for the student.	15%

- Committing any serious academic misconduct, such as **plagiarism** of previously published material, or **copying** in the exam or any other graded activity, **will imply not being able to pass the course in the ordinary assessment period**.
- The **use of AI** to create complete works or relevant parts, without citing the source or the tool or without being expressly allowed in the description of the work, will be considered plagiarism and regulated according to the General Regulations of the University.
- At the beginning of the term the professor will announce the office hours for the course. Tutorials are an essential part of the development of the course, and students may attend tutorials during the course within those office times, but it is recommended that they are arranged in advance with the professor.
- Any non-face-to-face learning activity that requires the submission of an assignment/document, etc. will be submitted by the student through Moodle, always in PDF format.
- To be able to take the final exam, students must not have missed **more than one third of the classes without justification**. If this requirement is not met, the student may lose the right to be assessed both in the ordinary and extraordinary assessment period (art. 93-1 of the General Regulations). Failure to attend to the first hour of a two-hour lecture, means having missed the whole session in terms of attendance, regardless of whether or not the student attended the second hour.
