## TEACHING METHODOLOGY

### General methodological aspects of the subject

Face to face methodology: Activities:

• Master lesson: The topics and concepts that are most difficult for the student to understand will be developed, encouraging the participation and discussion of theoretical and practical problems. You should read the topics in advance in the reference manual or in the presentations posted in Moodle.

• Comments for text: Some of the authors studied will be read in class to share the conclusions reached in these texts. Legal, doctrinal, jurisprudential and other texts will be analyzed.

• Practical case studies: Practical cases will be made on topics raised in classes, with the aim of putting the concepts learned into practice.

Non classroom methodology: Activities:

• Personal study of the student: Study of the concepts and topics presented in the master lesson. It is recommended to read materials and/or bibliography available.



- Autonomous text work: The student will be provided with texts that he/she must read and work on individually in order to produce text commentaries.

- Team work on case studies: It will be oriented towards the preparation of practical cases and the resolution of practical problems.

## Ratings

The exam will take place at the end of the quarter and will consist of some theoretical, practical and/or textual questions.

The student must demonstrate that he knows the main concepts explained and that he has developed the ability to identify them in the texts and to expose them and relate them to different arguments. It will also be appreciated that he has developed a personal and critical vision on the topics discussed, supporting his point of view in a sound legal-ethical-deontological argumentation. The examination will represent 75% of the final grade of the subject, but it will be necessary to pass it (5 out of 10) in order to take into account the remaining 25% of the continuous assessment activities carried out during the course.

In the examination of the second call (extraordinary call) will account for 75% of the final qualification of the subject, but it will be necessary to pass it (5 out of 10) to take into account the remaining 25 per cent for on going evaluation activities carried out during the course. In the event that the qualification of the examination of the extraordinary call was higher than this weighting, it will be the qualification of this examination that will be taken into account exclusively for the final qualification.

The assessment of third and subsequent students will be carried out by counting the final examination with 100% of the qualification.

Each serious misspelling will result in a penalty of 0.5 points in the exam score in any call.

On the regime applicable to out-going students, the final examination shall be taken as 100% of the qualification.

In-coming students shall be subject to the same academic regime as ordinary students, with the exception of the penalty for misspellings.
