NOTES ON CONTRIBUTORS

Dr. Gabriele Abbondanza is Marie Curie Fellow (a leading EU position) at the Complutense University of Madrid (Spain); Associate Researcher at the School of Social and Political Sciences of the University of Sydney (Australia); and Associate Fellow at the Italian Institute of International Affairs—IAI (Italy). He specialises in Australian and Italian foreign and security policy; irregular migration; the Indo-Pacific; and middle power and great power theory. He has published widely on these subjects, including articles in leading journals such as *International Affairs*, *International Political Science Review*, *European Political Science*, and *History of Political Thought*, and is co-editor, with Thomas Wilkins, of “Awkward Powers” (Palgrave Macmillan, 2021). Dr. Abbondanza currently teaches a number of courses related to international relations, security studies, and irregular migration, and frequently contributes to media and public debates concerning his fields of expertise.

Dr. Francesco Bailo is a Lecturer in data analytics for the social sciences at the University of Sydney. His research focuses on the impact of media and internet technologies on politics.

Prof. Loretta Baldassar is Professor in Anthropology and Sociology, Vice Chancellor Professorial Research Fellow, and Director of the Social Ageing (SAGE) Futures Lab, Edith Cowan University. Baldassar is one of Australia’s leading and most highly cited social scientists. She was named Australian Research Field Leader in Migration Studies as well as Ethnic

and Cultural Studies in 2020, 2021, and 2022, (The Australian Research Magazine 10/11/2022). Baldassar is Vice President of the International Sociological Association Migration Research Committee and Regional Editor for the journal, *Global Networks*. Baldassar has been a Chief Investigator on over 50 research projects, 20 as Lead. She is a highly regarded supervisor, with 26 Ph.D. completions and 7 international postdoctoral fellowships. Her career has been devoted to better understanding the impact of migration on families and communities, with a focus on social care and the role of social support networks, intergenerational relations, the ageing process, and the social uses of new technologies.

Dr. Simone Battiston is Senior Lecturer in History and Politics at the Department of Humanities and Social Sciences, Swinburne University of Technology. His research examines different aspects of post-war Italian emigration, with a particular attention to the Australian context: external voting behaviour, history and memory of radical migrants, and migrant media history. Battiston has published widely; his monograph, *Immigrants Turned Activists: Italians in 1970s Melbourne*, was published by Troubador Publishing (Italian Studies Series) in 2012. He co-edited, with Stefano Luconi and Marco Valbruzzi, *Cittadini oltre confine. Storia, opinioni e rappresentanza degli italiani all'estero*, published by Il Mulino in 2022. Battiston is the recipient of the 2001 Honours Thesis Award (Friuli-Venetia Julia Regional Government) and the 2007 PhD Thesis Award (Giovanni Agnelli Foundation-Altretaliae Research Centre). He is an executive member of the Australian Migration History Network, and a member of the Australian Historical Society and of the Australian Society for the Study of Labour History.

A/Prof. Andrea Benvenuti is Associate Professor in Politics and International Relations at the School of Social Sciences, University of New South Wales, Australia. He currently teaches twentieth-century history and diplomacy at both undergraduate and postgraduate levels. His research interests lie in post-1945 international history with a strong focus on the Cold War in both Asia and Europe. He recently published *Cold War and Decolonisation: Australia's Policy towards Britain's End of Empire in Southeast Asia* (NUS Press, 2017) and *China's Policy: The Emergence of a Great Power* (Routledge, 2022) with Chung, Khoo, and Tan. He is currently completing two books—a co-authored two-volume monograph on the role of western powers in Asia from the end of the First World War to the end of the Cold War (Bloomsbury) and a single-authored

book on Nehru's non-alignment in the 1950s (Hurst). He has a D.Phil. in International Relations from Oxford University, an M.A. in research from Monash University, and a B.A. Hons from the University of Florence.

Dr. Matteo Dutto leads the research group of the Monash University European Research Foundation, overseeing the identification of funding opportunities across local, national, and European grant schemes, and stakeholder engagement with academics, industry partners, and policymakers. Before joining the Monash University European Research Foundation, he was a postdoctoral researcher on the *Youth in the City* research project. Matteo is an Associate Research Fellow in the School of Languages, Literatures, Cultures and Linguistics at Monash University. His research employs decolonial, digital, and participatory action methodologies to explore how cultural producers collaborate with Indigenous, migrant, and multi-ethnic communities to produce transmedia and trans-cultural counter-narratives of belonging and identity. His monograph *Legacies of Indigenous Resistance* was published in 2019 and shortlisted in 2021 for the ASAL Alvie Egan award.

Dr. Giulia Marchetti is a Research Associate for the YMAP Project, a longitudinal, mixed-method study on youth mobilities to and from Australia originating from 5 countries (the UK, Italy, India, China, and Australia). She has recently completed her Ph.D. in Anthropology and Sociology on the Australian Research Council funded project, YMAP—Youth Mobilities Aspirations and Pathways—led by Prof. Anita Harris (Deakin University), Prof. Loretta Baldassar (Edith Cowan University), and Prof. Shanthi Robertson (Western Sydney University). Her thesis explored how transnational mobility impacts the identity and youth-to-adulthood transitions of young Italians who have moved to Australia and those who have returned to Italy.

Dr. Ilaria Stefania Pagani is a cancer researcher at the South Australian Health and Medical Research Institute, Adelaide, and affiliated senior lecturer in health and medical science at The University of Adelaide. She is leading her programme of research as Cancer Council fellow investigating new targeted therapies for blood cancer patients. She is a proud and active member of the Italian community in Australia where she contributes as President of the Association of Italian Researchers in Australasia, and treasurer of Com.It.Es South Australia. Funder of

Chronic Myeloid Leukaemia Australia Patient's Association, she is advocating for health equity ensuring a better care for cancer patients in Australia and worldwide.

His current research focuses on decolonial and transcultural approaches to migration and ethnic history—including a special forum in the journal *Altretalia* on decolonising Italian migration to Australia, and the articles *Migrant Lives on First Nation Land: Greek-Australian Memories of Titjikala in the 1960s* (with Maria Pallotta-Chiarolli; *Journal of Intercultural Studies* 43.5 2022); *Mio figlio è color pesca: vita, attivismo e ricerca antirazzista* (Voci XIX 2022), and *Mapping transnational lives: patterns of dislocation and reorientation in contemporary carto-graphic memoirs* (with Barbara Pezzotti, *Journal of Graphic Novels and Comics* 2023). He also conducts participatory research projects on the role of art and sport in informal processes of transculturation within superdiverse cities.

Dr. Kurt Sengul is a sessional lecturer and tutor at the University of Sydney, Australia. His research focuses on the communication and discourse of the populist far-right in Australia.

Dr. Tiziana Torresi is Senior Lecturer in Political Theory at the University of Adelaide.
