Contribution of the course to the professional profile

Public International Law course is part of the subjects taught in the area of Public International Law and International Relations. The main objective of the course is to help the student understand the basic concepts of International law and its importance in the international society nowadays.

At the end of the course, the student will be able to use a practical as well as a scientific approach to identify the current issues concerning the international legal framework ruling the relations between the actors of the international society.

II. COMPETENCES TO BE IMPROVED

General Competences

Instrumental

To improve oral and written communication skills in a second language.

To identify the legal sources and to apply them to specific situations

The student must know the different sources of International Law and be able to apply them correctly to

specific situations in order to extract the legal consequences of each case.

Professional (Know-how)

Discursive and argumentative skill.

- 1. Writing skills: fluent, clear and organized structuring of ideas; command of specific vocabulary.
- 2. Oral skills: ability to speak fluently and confidently; organized structuring of ideas; persuasion in the presentation of arguments; using the appropriate register and specific terminology.

Independent study methodology

- The students must read and study the required reading before each lecture and shall be prepared to discuss the topic in class.
- Meeting with classmates in order to work on the group assignments.
- Resolution of case studies
- Writing essays or reports on specific issues related to International Law.

EVALUATION

Ordinary session:

- Exam (70%): the exam will consist on a situation the student has to analyse applying the theoretical knowledge acquired as well as the sources of International.
- Group presentations (including assignments) (30%): The subject of the presentations will be assigned by the professor at the beginning of the semester. Guidelines will be available in Moodle. The students will be free to form the groups as they wish. The professor will set a deadline to do so. After the deadline, the professor will form groups in order to include every student in one group. At least one judgment/advisory opinion of the International Court of Justice (worth 20% of the final mark) will be done per group. The presentations of assignments will be worth 10%.

Extraordinary session / Third session and onwards:

The exam will represent 70% of the overall grading and the group presentations 30%. If the student passed one block of activities (exam, assignments or presentation), the mark can be maintained for the extraordinary session.

Please note that the student is always required to pass the exam (at least, 5/10) to allow the professor to take into account the marks obtained in other activities (group presentation and assignments).
