#### **Tentative Work Calendar**

### AREA 1

Students should immediately begin thinking about potential topics and meet with the MIEBL director to discuss any problems with finding a topic.

Each student is required to submit and defend a thesis based on a topic of his or her choice, but related to international and European business law. Students should spend the first month or two of the course becoming acquainted with the material. Once students have a general idea of the topic, please communicate it to the MIEBL Director, who will then assign you a supervisor. Over subsequent months, students will work with the supervisor to further develop the topic and produce a thesis of high academic quality.

#### **Topic Submission**

Students should submit a topic (even if not 100% clear) to Adam Director by October 22<sup>nd</sup>. A supervisor will be assigned, who will help students to clarify topic and begin working to find sources and develop an outline.
