Contribution of the course to the professional profile

This course, which belongs to the Area of Public International Law and International Relations, is focused in a number of goals. General Competences

Instrumental

- 1. To become skilled in the knowledge of the main rules and practical implementation of public international law and European law regarding immigration and refugee status (or other forms of international protection).
- 2. To become familiar with international and European case-law on immigration and asylum with special attention to the case-law of ECtHR and the ECJ.

Professional (Know-how)

Discursive and argumentative skill.

The acquisition of this competence involves knowledge and mastery of the techniques of legal oratory, indispensable for the exercise of the profession: in written language; fluency, clear and orderly structuring of ideas; knowledge of legal terminology; spoken language; accuracy, conciseness and persuasion in the presentation of arguments.

Learning outcomes. With the achievement of this competence, the student proves:

- 1. Ability to express him/herself correctly and fluently in writing, properly managing presentation of ideas and arguments (command of legal vocabulary, drafting and structuring of legal documents...).
- 2. Ability to speak fluently and confidently, ordering ideas and using the appropriate register to the recipient (public expert or layman ...)

V. METHODOLOGY

Classroom activities or face-to-face methodology

Lectures include introduction to each thematic area and general explanations about their content, as well as guidance and comments on the papers that students should have read and worked before the class. Active participation of students and in-depth discussions are expected.

Independent study methodology

- Knowledge of Public International Law and European Union Law are required to follow the Course.
- Students shall read and work on the papers previously assigned to each lecture (available on Moodle) and shall be prepare for the future discussion to be held in class about the topic.
- Students shall write an Essay (3000 4000 words) on a topic related to the contents of the course, to be agreed with the professor. A list of topics and drafting guidelines will be available on Moodle.
- The Essay must be handed in on the date of the exam at the latest and an electronic copy shall be sent before the exam through the Moodle website as a *Turnitin* exercise.
- Students shall also prepare an oral presentation of their Essay that will take place the day of the written and oral Exam.

EVALUATION

Ordinary session:

- Oral exam (60%): the exam will consist of the oral presentation of the written essay prepared by the student, as well as questions related to the contents of the course.

- Written paper or essay (30%): 3000 – 4000 words. The subject of the paper will be a topic related to the contents of the course, chosen by the student in agreement with the professor. A list of topics and drafting guidelines will be available on the Moodle website.

- Active participation in class (10%): Students are expected to actively intervene in each session of the course, after having duly prepared the materials corresponding to each lecture.

Extraordinary session / Third session and onwards:

The oral exam and the written paper will represent 70% and 30%, respectively, of the final evaluation. The pass mark obtained at the written essay in the ordinary session can be maintained for the extraordinary session.

Students participating in exchange programs abroad (out-going students):

The oral exam and the written paper will represent 70% and 30%, respectively, of the final evaluation.

*In any session, the student is required to pass the exam so that the marks obtained in the other activities can be taken into account.
