Descriptor	This course provides an in-depth exploration of the European reality from a multidisciplinary perspective, focusing on Europe's history, politics and international presence. Students will analyse the evolution of the conceptualisation of Europe, the impact of historical events such as the World Wars and the Cold War on the European identity, and the ongoing process of European integration through the European Union. The course will also address contemporary issues offering a comprehensive understanding of the challenges and opportunities facing Europe today. Through lectures, readings, discussions, in-class activities and a simulation game, students will gain critical insights into the complexities of the European region and its role in the global context.

# **DATOS ESPECÍFICOS DE LA ASIGNATURA**

## Contextualización de la asignatura

## Aportación al perfil profesional de la titulación

The aim is to provide students with a general overview of the main issues that defined the course of European history during the 20<sup>th</sup> century (and first decades in 21<sup>st</sup> century!) This includes the study of conflicts between European great powers and states, main actors' internal political developments, cultural issues, analysis of the mentalities and the ideologies that shaped the continent during last century.

Essay writing will allow the student to explore themes in more depth.

The student will become familiar with changing geo-political pattern of Europe nation-states and empires; the causes and effects of wars; the main political movements; changes in living standards; integration process; and the range of experiences that Europeans have lived through. The student will be able to read a complex historical text.

Course seminars will be thematic in organisation. <u>Students will prepare for seminars by reading set texts in advance</u>. Discussion of these texts will form the basis of seminar discussion.

Students will be penalised for late submissions unless granted an extension in advance causes for requesting extensions are illness or a serious personal problem.

#### How to succeed in this course

The course emphasizes reading, debating, and writing skills that are sometimes unfamiliar, but essential. There are no notes available, but all materials needed would be available. The readings are only the beginning, as they are a springboard in many lectures. You should be



taking notes on the readings and deepening your knowledge of the historical issues through more reading.

At the end of the course, students will have a sophisticated understanding of contemporary European political issues and can place them within the broader context of 20<sup>th/21st</sup> century history.

# Aspectos metodológicos generales de la asignatura

The subject "Regional Studies: Europe" implements a combination of different methodologies with the aim of ensuring comprehensive and dynamic learning for students.

### **Metodología Presencial: Actividades**

Throughout the semester, **lectures** will provide the theoretical and conceptual frameworks necessary to understand and analyze the key issues shaping the current state of affairs in Europe. These sessions will be supplemented by active learning methodologies, including **inclass activities** such as debates, case studies, and a simulation game, among others.

The objective of this approach is to foster an effective learning process, enabling students to apply the knowledge gained to their future professional careers. This methodology also encourages the development of **critical thinking and analytical skills**, both within and beyond the classroom setting.

**Active participation** is a cornerstone of the course, playing a crucial role in its overall effectiveness and in the student's own learning journey.

## Metodología No presencial: Actividades

The combination of lectures and active classroom methodologies will be supplemented by **independent work** on the part of the student. The aim of these autonomous activities is to strengthen the student's **research and reflection skills**, thereby reinforcing the knowledge acquired during the lectures.

To complement the material covered in class, students will be provided with readings to complete throughout the semester.

Simulation Game	Over the span of three weeks, students will engage in a simulation game aimed at resolving an international crisis. Each student will represent a key stakeholder in the crisis and must work to safeguard their respective interests.
Final Briefing	Additional information regarding the format and content will be provided throughout the course.
