Additional interest is given to the recent tendencies of protectionist national economic policies and how they affect the international trading system.

Related to Tema 3: Legal Principles – WTO/FTAs  Case preparation – topic related WTO cases are analysed  Each of the three working groups analyses and presents the following WTO cases in class.  Group 1 – Japan-Alcoholic Beverages II, Colombia-Textiles, US-Gasoline Group 2 – Japan-Alcoholic Beverages II, Colombia-Textiles, US-Shrimps Group 3 – Japan-Alcoholic Beverages II, Colombia-Textiles, Brazil-Re-treaded Tyres	Preparation of WTO cases out of class, and the written part of the assessment - a 1-2-page case summary and oral discussion in class. The written summary is prepared in form of bullet points in class. It is essential that students revise in core readings with absolute details the related regulation on MFN, national treatment and general exceptions.	10%
Related to Tema 4: Tariff and Non-Tariff Barriers / TBT/SPS  Debate Forum  Happy State is a WTO member emerging economy with increasing local consumption and important potential to export meat and meat products from cattle to the European Union. 40% of cattle farming for meat is concentrated through large producers of min. 300 heads (frequently more) representing 10% of all producers. Other producers are small producers of 1-20 heads. There is no sanitary regulation related to these products in Happy State. Modernization of the sector is essential public policy interest. Happy State government organized a discussion group to evaluate positions of interest groups. Happy State is also planning to sign an FTA with the European Union. It is expected that a common approach is decided at the meeting.	The Debate Forum discusses a specific regulatory issue in an organized manner, where negotiating positions are previously established and must be assumed through role play (mini-research out of class, and preparation of 1-page kick off statement out of class, group work, oral exercise in class).	15%

Group 1A- BigBeef – representing large producers Group 1B- SmallBeef – representing small producers Group 2A – EatBeef – representing consumers Group 2B – Happy State government officials Group 3A – ImportBeef – representing importers in Happy State Group 3B – ExportBeef – representing exporters of the European Union  Interest group positions' should be based on arguments resulting from mini-research. Common approach should comply with WTO norms and consider EU approach.  EC-Hormones (WTO case) must be revised to generate additional ideas for the Debate Forum. It is also expected that students are familiar with recent SPS discussions related to the TTIP and CETA; as well as recent EU beef market trends.

The Moot Court is to reconstruct a hypothetical case applying the rules of the WTO Dispute Settlement System (group work, written exercise out of class, oral exercise in class). The written part of the assessment is a 2-page DSS document depending on assigned group role.	10%

Pre-established concessions are only shared by the respective delegation. These previously established negotiating positions must be assumed through role play. It is designed to contextualize ideas discussed during the classes from the very personal stand point of each student. Mini-research and preparation of 2-page personal statement out of class and oral presentation and debate groups in class.	15%
